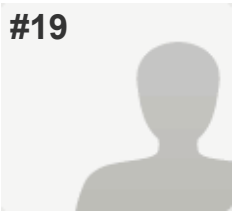

In general, I don't believe it is necessary to make it harder for felonies to be reduced to misdemeanors. If a prosecutor has good reason to keep a charge as a felony, they should have the ability to do so and also if they believe that the interests of justice should allow for a charge to be reduced to a misdemeanor, they should have that authority also. Taking away this type of discretion I believe ultimately has an opposite impact on solving the underlying issue trying to be resolved (animal abuse) because the individual criminalized will still ultimately get out and often without the type of rehabilitation that might have prevented him/her from doing it again if the answer is simply a harsher penalty.
