Have you ever been involved in any animal protection issues?

Comments:

I have served on the Humane Society of the US, AZ State Council, for a few years while on Council and worked with HSUS, Bailing Out Benji, and local animal-welfare organizations. As a two-term councilmember and the vice mayor of Tempe, I worked with my phenomenal policy Aide, Kristin Gwinn and a host of animal welfare groups to create the an Office of Animal Welfare. The Mayor's Office of Animal Welfare in New York City mentored us as we crafted the first city animal welfare policy office in Arizona. The Office leads a phenomenally successful community cat program as well as places abandoned animals, offers emergency temporary care, spay/neuter vouchers, pet supplies and food, and resource navigation. We have TNRed over 2000 cats and offer cat caregiver support and community education program. I led and passed "June's Law," which banned the commercial sale of pets in Tempe and sought to end the puppy mill pipeline into our city. I led and passed an anti-tethering ordinance in Tempe in 2016.

I could tell you hundreds of stories about the dogs that have impacted my life. And they all have been integrated into my community campaigning. They include: • An English bull terrier named Rupert, who was lost for over a month when he was 9 months old, sparking an intensive search in the community. He was a lovable -- and irascible -- fellow whose starring role in the student-created Live Action Toy Story Project led to his quasi-celebrity stature. See Rupert's Facebook site. • A backyard breeder, a Boston Terrier named Sadie, who we had for 7 months and captured my heart. She died of mammary cancer, and it broke my heart. • My dear dog Ginny, who was thrown from a car and is now my devoted girl. • My grand dog Raja, who is the smartest pup I've ever loved. • June, the miniature greyhound whose life (and that of his mama, Nicole Galvan) inspired our Tempe legislation, "June's Law."
